

ORDINANCE NO. 2014-02

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 74-38 OF THE TOWNSHIP CODE ENTITLED, "WATER/SEWER UTILITY".

NOW, THEREFORE, BE IT ORDAINED BY the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, that Chapter 74 of the Township Code entitled, "Water/Sewer Utility", in particular Article II entitled, "Water/Sewer Utility" is hereby amended and supplemented as follows:

SECTION 1. The Township amends and supplements Chapter 74 of the Township Code entitled, "Water/Sewer Utility" to include new Section 74-39 which shall read as follows:

There is hereby adopted for the Township of Barnegat Rules and Regulations entitled, "Rules and Regulations for the Sanitary Sewer System, Township of Barnegat, Ocean County, New Jersey" dated December, 2013. Said Rules and Regulations are on file in triplicate in the office of the Township Clerk, 900 West Bay Avenue, Barnegat Township, New Jersey and are available for inspection during normal business hours."

SECTION 2. The Township Committee authorizes the Mayor, Township Clerk and Township Administrator to execute any and all necessary documents in order to implement the intent of this Ordinance.

SECTION 3. The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of the Ordinance shall not be affected thereby.
