

ORDINANCE 2014-26

**AN ORDINANCE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN,
STATE OF NEW JERSEY AMENDING AND SUPPLEMENTING CHAPTER
44A OF THE CODE OF THE TOWNSHIP OF BARNEGAT ENTITLED "FEES,
MISCELLANEOUS"**

NOW, THEREFORE BE IT ORDAINED BY the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey that Chapter 44A of the General Code of the Township of Barnegat is hereby amended and supplemented as follows:

SECTION 1. 44A-1 Entitled "Purpose" is hereby amended as follows:

The purpose of this ordinance is to finalize miscellaneous charges of the various departments of the Township of Barnegat. The following fees may be established annually by a resolution of the Township Committee as may be needed to reflect necessary fees for individual purposes.

SECTION 2. 44A-2(A) Entitled "Township Clerk's Office" is hereby amended as follows:

44A-2A.1 Photocopies of oversized material, such as maps or site plans, shall be charged the following fees: 24"x36" five dollars (\$5.00), 36"x48" ten dollars (\$10.00).

Section 44A-2(B) Flood Letters: Flood letters issued by the Township shall require a fee of ten dollars (\$10.00) per letter requested.

SECTION 3. 44A-3 Entitled "Tax Collector's Office" is hereby amended as follows:

44A-3(C) is hereby deleted in its entirety

44A-3(F) is hereby deleted in its entirety

44A-3(H) is hereby deleted in its entirety

SECTION 6. 44A-6 Entitled "Fee for administration of patrolman's test" is hereby amended as follows:

The township hereby establishes a fee of seventy-five dollars (\$75.00) to be paid by the applicant to the township, to help defray

its administrative costs in the implementation of the police patrolman's examination.

SECTION 7. Entitled "Fee for refuse collection and containers used with automated garbage trucks" is hereby deleted in its entirety.

SECTION 8. Entitled "Municipal Court discovery fees" is hereby amended as follows:

- B. (1) Photocopy charge of five cents (\$.05) per 8 1/2"x11" letter size page and seven cents (\$.07) per 8 1/2"x14" legal size page or larger.
- (2) Deleted in its entirety
- (3) Deleted in its entirety
- (4) same
- (5) Twenty-eight cents (\$.28) or thirty-five cents (\$.35) based on size, for the envelope for any discovery sent by mail

- (7) Duplication of compact discs shall be charged a fee of forty-one cents (\$.41) per CD, DVD's a fee of sixty cents (\$.60) per DVD.
- (8) same
