**RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY AUTHORIZING THE AWARD OF A CONTRACT TO PYROTECHNICO FOR THE CALENDAR YEARS 2015 AND 2016 FOR JULY 4<sup>TH</sup> FIREWORKS WITH LEAD AGENCY CITY OF OCEAN CITY, AND COOPERATIVE PRICING SYSTEM MEMBERS — (251COCCPS)**

**WHEREAS**, specifications were authorized for advertisement on February 26, 2015 through the Ocean City Cooperative Pricing System for Firework Shows for Calendar Years 2015-2016 for the Township of Barnegat (251COCCPS); and

**WHEREAS**, the Notice to Bidders was advertised in the Ocean City Sentinel on Wednesday, March 4, 2015, the Notice to Bidders was posted on the City of Ocean City's Website [www.ocnj.us](http://www.ocnj.us) and the specifications were distributed to three (3) Prospective bidders(s); and

**WHEREAS**, the City of Ocean City has acted as the Lead Agency for City of Ocean City Cooperative Pricing System (251COCCPS) and City Contract #15-01. Firework Shows for Calendar Years 2015-2016 for the Township of Barnegat which obtained pricing for the participating cooperative members through a competitive bid process: and

**WHEREAS**, the Township of Barnegat is by this resolution only awarding the Township of Barnegat's portion of the bid proposal for the July 4th Firework Shows for the Calendar year 2015-2016 for the Township of Ocean; and

**NOW THEREFORE BE IT RESOLVED** this 4<sup>TH</sup> day of May 2015 by the Township Committee, Township of Barnegat, County of Ocean and State of New Jersey as follows:

1. The Township hereby awards a contract to Pyrotechnico for fireworks to be conducted at the July 4, 2015 celebration, rain date, July 5, 2015 and July 4, 2016, rain date July 5, 2016.
