

**RESOLUTION 2015-233**

**RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, TERMINATING THE EMPLOYMENT OF RICHARD JODICE AS AN EMPLOYEE OF THE TOWNSHIP OF BARNEGAT.**

**WHEREAS**, the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the “Township”), is concerned about the current employment status of an employee, Richard Jodice; and

**WHEREAS**, Mr. Jodice has not been working with the Township for more than one year, and as a result of physical and psychological examination reports, it appears that he will no longer be able to perform the functions which he was previously performing with the Township; and

**WHEREAS**, the Township has no light duty position that can be offered to Mr. Jodice; and

**WHEREAS**, the Township is in need of filling the void left by Mr. Jodice in order to best serve the Township, its residents, and tax payers.

**NOW, THEREFORE, BE IT RESOLVED**, this 20<sup>TH</sup> day of July, 2015, by the Township Committee of the Township of Barnegat, County of Ocean, State New Jersey, as follows:

1. The Township terminates the employment of Richard Jodice, effective immediately.
2. The Township authorizes and directs the Mayor, Township Clerk, Township Administrator to execute any and all necessary documents in order to implement the intent of
