**RESOLUTION OF THE TOWNSHIP OF BARNEGAT,
COUNTY OF OCEAN, STATE OF NEW JERSEY TO
AUTHORIZE THE AWARD OF A CONTRACT FOR ONE
(1) MOTORCYCLE FOR THE POLICE DEPARTMENT TO
ATLANTIC COUNTY HARLEY-DAVIDSON**

WHEREAS, the Township advertised for the receipt of bids on September 2, 2015 for one (1) new and unused 2016 Harley Davidson FLHTP “Electra Glide” Solo Law Enforcement Motorcycle for the Police Department; and

WHEREAS, at the time and place for the receipt of bids, a total of one (1) bid was received for the project; and

WHEREAS, the single bid of \$25,000 was submitted by Atlantic County Harley-Davidson, 219 E. White Horse Pike, Galloway, NJ 08205; and

WHEREAS, the Township Attorney has reviewed the bid documents submitted by Atlantic County Harley-Davidson, and, has found that the bid appears to be reasonable and is in substantial compliance and has recommended an award of the contract to purchase one (1) new and unused 2016 Harley Davidson FLHTP “Electra Glide” Solo Law Enforcement Motorcycle for the Police Department to Atlantic County Harley-Davidson; and

WHEREAS, the Chief Financial Officer has certified that there are sufficient funds available for the award of this contract; and

WHEREAS, it is the desire of the Mayor and Township Committee to act upon the recommendation of the Township Attorney.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

1. That a contract shall be awarded to Atlantic County Harley-Davidson 219 E. White Horse Pike, Galloway, NJ 08205, as the responsible bidder, for purchase one (1) new and unused 2016 Harley Davidson FLHTP “Electra Glide” Solo Law Enforcement Motorcycle, in the total bid amount of \$25,000.00.
2. That a certified copy of this resolution shall be forwarded to the Chief Financial Officer of Barnegat Township, to The Barnegat Police Department, and to Atlantic County Harley-Davidson.
