

RESOLUTION 2015-303

RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, APPROVING AMENDMENT TO THE EXISTING COLLECTIVE BARGAINING AGREEMENT WITH THE BARNEGAT TOWNSHIP POLICE SUPERIOR OFFICER'S ASSOCIATION SO THAT THE NEW AGREEMENT EXTENDS THROUGH DECEMBER 31, 2021.

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has previously entered into Collective Bargaining Agreements ("CBAs") with the Barnegat Township Police Superior Officers Association ("SOA"); and

WHEREAS, the last CBA expired on December 31, 2013; and

WHEREAS, negotiations by and between representatives of the Township and SOA have been ongoing, and have resulted in a satisfactory resolution; and

WHEREAS, the Township Committee has received and carefully reviewed the proposed amendments to the prior SOA which will extend, other than as modified herein, all terms and conditions of the prior CBA through December 31, 2021; and

WHEREAS, the Township believes that the finalization of these negotiations and acceptance of the CBA is in the long term best interests of the Township, the SOA, its residents and taxpayer.

NOW, THEREFORE, BE IT RESOLVED, this 21 day of September, 2015, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

1. The Township accepts the proposed amendment to the prior Collective Bargaining Agreement, a true copy of which is on file at the office of the Township Clerk and can be reviewed during normal business hours.
