**Flood Hazard Area Emergency Rule**

**Permit By Rule (7:7-7.2(a) 8) for Expansion or Relocation of Existing Home in the SFHA**

- 1) Is the proposed structure a single family dwelling? Y or N
- 2) Is the proposed construction located outside of a beach, dune or wetland? Y or N
- 3) Is the structure being relocated landward or parallel to the MHWL (mean high water line) of the previously constructed structure footprint? Y or N
- 4) Is or was the previous structure habitable? Y or N
- 5) Is the footprint of the proposed home equal to or less than 400 sq ft more than the original footprint? Y or N
- 6) Is the proposed driveway made of porous material, or pitched to drain onto permeable areas of the site? Y or N
- 7) Is the lowest habitable floor being raised to at least one (1) ft above the BFE required for this lot, per the best available data maps for this lot? Y or N
- 8) Is there an existing municipal sewer on site? Y or N

**If you answered no to any question, this project is not eligible for this Permit By Rule, and you must apply to the DEP for a permit to construct/reconstruct your home.**
