RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING RELEASE OF A STORMWATER MAINTENANCE CASH GUARANTEE TO FRANCIS VOGELMAN

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the “Township”) has received a request from Francis Vogelman, 1575 Route 554, Barnegat, New Jersey, for a release of a four (4) year storm water maintenance bond in the amount of \$7,736.00; and

WHEREAS, the funds were received in cash by the Township on March 19, 2008; and

WHEREAS, the requirement was that the maintenance bond be posted for a four (4) year term, which expired on March 19, 2012; and

WHEREAS, the issue has been reviewed by the Township Engineer and by letter dated February 3, 2016. The Township Engineer has indicated that he has no objection to the cash bond being released.

NOW, THEREFORE, BE IT RESOLVED, this 1st day of March, 2016, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

1. The Township accepts the recommendations of its Township Engineer and authorizes a release of a cash maintenance bond in the amount of \$7,736.00 to Francis Vogelman.
