**RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY AUTHORIZING THE PURCHASE OF MODEL YEAR 2016 ROLL OFF DUMP TRUCK AND OPTIONAL EQUIPMENT THROUGH THE N.J.P.A. COOPERATIVE PRICING SYSTEM**

**WHEREAS**, N.J.S.A. 40A:11-11(5) authorizes contracting units to establish a Cooperative Pricing System and to enter into Cooperative Pricing Agreements for its administration; and

**WHEREAS**, the Township of Barnegat, has offered voluntary participation in a Cooperative Pricing System for the purchase of goods and services; and

**WHEREAS**, on February 9, 2016, the Township of Barnegat's Governing Body authorized the Township of Barnegat to become a member of the National Joint Powers Cooperative Pricing System, membership #31466; and

**WHEREAS**, the Township of Barnegat, pursuant to N.J.S.A. 40A:11-1 et seq., may by resolution and without advertising for bids, purchase any goods or services under the National Joint Powers Cooperative Pricing System for any contract entered into on behalf of the Township of Barnegat; and

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

**WHEREAS**, The Township is authorized to purchase certain goods or services from those approved National Joint Powers Alliance Cooperative Pricing System Vendors.

**WHEREAS**, it's the desire of the Township's Public Works Department through the National Joint Powers Alliance Cooperative Pricing System to utilize Eagle Truck Equipment, Inc., in accordance with the NJPA contract #060612-WQI to accept the lowest responsible price quote of \$160,075, including freight and delivery for, specifically, one (1) new 2016 Peterbilt truck Model 348, with a new Galbreath U75-OR-174, 75,000# capacity roll-off hoist and optional equipment, pursuant to all conditions of the individual contract.
