

RESOLUTION 2016- 198

RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING A CONTRACT FOR THE UNIFORM RENTALS ON A WEEKLY BASIS TO AMERICAN WEAR, INC.

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the “Township”) has solicited bids for the Uniform Rentals (the “contract”); and

WHEREAS, the bids were solicited by the Township in accordance with the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1, *et seq.*; and

WHEREAS, the sole bid submitted in response to the bid solicitation is from American Wear, Inc. as follows:
