

**RESOLUTION 2016-226**

**RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING A CONTRACT WITH SHORE CONNECTION, INC. FOR CONSTRUCTION WORK AT THE BARNEGAT BASIN**

**WHEREAS**, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the “Township”) has solicited informal bids for work to be undertaken at the Barnegat Basin (the “contract”); and

**WHEREAS**, a proposal has been submitted by Shore Connection, Inc. to undertake the necessary work in accordance with Invoice dated May 26, 2016, calling for a payment of \$14,430.00 upon completion of the project; and

**WHEREAS**, the project intends to address and resolve certain drainage issues at the Basin, all to the betterment of the taxpayers and the residence of the Township; and

**WHEREAS**, the award of this contract is accordance with the Township’s budgetary constraints.

**NOW, THEREFORE, BE IT RESOLVED**, this 14<sup>th</sup> day of June, 2016, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

1. The Township accepts the recommendations of its administrative staff and awards a contract to Shore Connection, Inc. for the construction work to be undertaken at the Barnegat Basin in accordance with the proposal dated May 26, 2016, at a total cost of \$14,430.00.
