RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AWARDING A TWO (2) YEAR CONTRACT TO WATER WORKS SUPPLY CO., INC. FOR PROCUREMENT OF WATER METERS

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (the "Township") has solicited bids in accordance with the New Jersey Open Public Contract Law, N.J.S.A. 40A:11-1 et seq., for the procurement of water meters (the "Project"); and

WHEREAS, as a result of the bid solicitation one (1) bid has been received from Water Works Supply Co., Inc. in the amount of \$32,935.50.

WHEREAS, after consultation with the Township's professional staff, the Township finds that subject to the budgetary constraints the bid should be awarded to the only responsible bidder, Water Works Supply Company.

NOW, THEREFORE, BE IT RESOLVED, this 5th day of July, 2016, by the Township Committee of the Township of Barnegat, County of Ocean, State New Jersey, as follows:

1. Water Works Supply Co., Inc. is hereby awarded the two (2) year contract for the procurement of water meters in the amount of \$32,935.50 from 7/5/2016 to 7/5/2018.
2. The Township authorizes and directs the Mayor, Township Clerk and Township Administrator to execute any and all necessary documents in order to implement the intent of this Resolution.
