**RESOLUTION AUTHORIZING AN AMENDMENT  
TO PER UNIT CHARGE FOR SOLID WASTE  
COLLECTION FOR THE PERIOD OF JULY 1, 2016  
THROUGH SEPTEMBER 30, 2016**

**WHEREAS**, the Township Committee of the Township of Barnegat has extended the Contract for solid waste and recycling collection with Waste Management of New Jersey, Inc.; and

**WHEREAS**, the current Contract expired on June 30, 2016; and

**WHEREAS**, due to increased costs, the Contractor has advised that the extension of the Contract will result in an increase in the per unit cost to \$7.89 per unit per month; and

**NOW, THEREFORE BE IT RESOLVED** this 2<sup>nd</sup> day of August, 2016 by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

1. The Township hereby authorizes the payment for solid waste collection at the rate of \$7.89 per unit per month with Waste Management of New Jersey, Inc. for the period from July 1, 2016 through September 30, 2016 and until such time as the Township has awarded a new Contract for solid waste and recycling collection.
