**RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE

1. Martin J. Buckley, Esq., Timothy J. McNichols, Esq. and Christopher J. Dasti, Esq. all of the Law Firm of Dasti, Murphy, McGuckin, Ulaky, Koutsouris & Connors, P.C. are hereby appointed as Alternate Municipal Prosecutor(s) for the Township of Barnegat.

2. The Township authorizes and directs the Mayor, Township Clerk, and Township Administrator to execute any and all necessary documents in order to implement the intent of this Resolution.


