**RESOLUTION OF THE TOWNSHIP COMMITTEE OF
THE TOWNSHIP OF BARNEGAT, COUNTY OF
OCEAN, STATE OF NEW JERSEY, AUTHORIZING
THE RELEASE OF THE TEN YEAR INSPECTION
PROGRAM GUARANTEE FOR BLOCK 81, LOT 8.01,
BARNEGAT TOWNSHIP, NEW JERSEY**

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has received a request from the Applicant, Cliff Shoenberger, for a release of a Ten Year Inspection Program Guarantee for the stormwater management system affecting Block 81, Lot 8.01, Barnegat Township, New Jersey (hereinafter referred to as the "Project"); and

WHEREAS, the Township has received and review a letter of recommendation from its consulting engineer for the Project, John J. Hess, P.E., P.P. dated August 30, 2016; and

WHEREAS, the Township's consulting engineer has advised that the Applicant posted a ten year guarantee on May 23, 2016 and that his office has no objection to the cash bond being released; and

WHEREAS, the Township finds that the recommendations of its consulting engineer are appropriate, and in accordance with the Township Land Use Ordinance; and

NOW, THEREFORE, BE IT RESOLVED, this 4th day of October, 2016, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

1. The Township accepts the recommendations of its consulting engineer for the Project and authorizes a release of the cash bond in the amount of \$5,160.00.
