# **10. Committee Comments**

**Susan McCabe-** Wishing everyone a Happy New Year. I am very excited about this committee. I look forward to what we can accomplish this year.

**Frank Caputo-** Thank you to my family, wife and children, to my extended family the residents of Barnegat. I will do what is in the best interest for all of us. I believe we have top notch people up here that have Barnegat in their best interest.

**Al Cirulli-** Congratulation's to the Committee. This is an exceptional group. All their experience and expertise will serve the residents of Barnegat well.

**Al Bille-** Thank you to my family and friends. Congratulation to Mr. Novak, we have a great CFO, Tom. Between him and Marty along with us up here we have a great team. We will do what is best for our community.

**John Novak-** Thank you to Dee, Nancy and Florence for decorating the recreation center for this evening. Thank you to Michele, Donna and her staff. Thank you to Susan McCabe. She served during a hard time, with an Administrator that was on sick leave and with a new CFO coming in. She took time out of her life to be in town hall, which becomes a chore.

The selection process for mayor in Township Committee form of government is interesting, local politics at its best. There's ringing and wrangling, concessions and compromise the results of which, this year, are historic for this will be the first time where Barnegat's mayor will be subject to the five-minute timer. In reorganization meetings such as this, municipalities large and small gather and speeches are given. Those speeches often times include words like vision, journey, destiny, dreams they also afford an opportunity for the person giving the speech to tell you how great they are and how they will accomplish great things during their tenure in office. Eventually, vision and dreams journey to the destiny of reality, the reality of cost, revenue, finance, and other factors which are inevitable in local government.

A portion of our government faces the voters every election cycle. While somewhat unique amongst the spectrum of elected bodies, it certainly fosters accountability. The Township Committee form of government works for towns our size hence its overwhelming popularity throughout the state. However, the burden of re-election can produce unintended long term results.

Proverbs 28:12 says, Whoever conceals his transgressions will not prosper, but he who confesses and forsakes them will obtain mercy.

2015 was and interesting year. It brought two new Committeemen to the dais and saw the replacement of two key administration figures: the CFO and the Township Administrator. Ignorance is bliss and things are not always as they seem. It is now apparent that there is work to do to get our fiscal house in order. It would appear that he pressure to paint a pretty picture can result in a distorted image.

To perpetuate illusion would not foster trust. While it may be more pleasant on the ears to dream, 2016 is going to be a challenging year.

There are to be no secrets as between Township Committee members irrespective of affiliation or allegiance and, other than legally appropriate confidential or sensitive matters, there shall be no secrets from the public.

The imprisoned Apostle Paul in his letter to the church at Phillipi presumably somewhere between 53 and 61 A.D. said in (Philippians 2:3) Do nothing from selfish ambition or conceit, but in humility count others more significant than yourselves.

In reorganization meetings, someone is selected to sit in the center seat; in our Township Committee form of government that person, the Mayor, is an equal among five.

Each and every one of the five seated here today has a responsibility and a purpose. All count and all are to be heard. Proverbs 27:17 say that as *Iron sharpens iron-one man sharpens another*. Dialogue

and respectful disagreement are healthy and productive; we all do not always have to thin in unison.

As General George Patton is famously known to have said, if everybody is thinking alike, then somebody isn't thinking.

Arnold H. Glasow, a writer frequently cited in the Wall Street Journal, Forbes, the Chicago Tribune and many other publications who published his first book at age 92 said, A good leader takes a little more than his share of the blame, a little less than his share of credit.

Humility is a hallmark class. Evidence that the most powerful of all became a man and suffered the humiliation of death on a cross.

Elected officials who face the voters periodically seek to be popular. To be liked one must be trusted and for there to be trust there must be transparency. We must endeavor to be as transparent as possible. It will take time; trust must be earned, over time, and we must start now.

This year you are going to see Workshop meetings. In 2016 we will have Workshop meetings open to the public. One Friday morning each month in this room, we will meet publicly to craft an agenda for the upcoming Township Committee meeting. The dialogue about ideas and plans, this will be done in public and the public is encouraged to attend.

In 2016 there will be meet the Mayor opportunities. Dates, times and locations are to be determined and will be flexible. The privilege of getting to sit in the center seat and enjoy the title of Mayor has it responsibilities and primarily that must always be to the public.

Barnegat is a small town with a big heart. Our folk seek to get involved. There is a vast wealth of diverse knowledge and experience in this town; it should not be squandered or ignored. The five seated here are not bestowed with any monopoly on brilliance. In 2016 there will be, from time to time as issues present themselves, Mayor's Select Task Force(s). As the title suggest, these groups will be task specific and will, for limited periods of time, be created to research and investigate a particular issue then present findings and recommendations to the Township Committee. Although sometimes we may be tempted to think so, it's impossible to know everything about everything. On any given issue, specialized knowledge, experience and research efforts can assist this Committee and help the correct decisions to be made.

Proverbs 11:14 says, Where there is no guidance, a people falls, but in an abundance of counselors there is safety.

It's a new year with new folks in vital places. It is asked that cooperation be conferred, patience be provided, and that you pray for us and for Barnegat Township. We are a good town with good, caring people and we will do good things in 2016.
