RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AWARDING THE CONTRACT FOR A SUPPLY OF LIME TO REED & PERRINE SALES, INC.

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the “Township”) has solicited bids for the supply of lime for utilization by the Township in conjunction with the maintenance of its water system; and

WHEREAS, the bids were solicited in accordance with the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.; and

WHEREAS, two bids have been received by the Township in response to the bid solicitation as follows:

Univar USA, Inc. \$10.50/Bag - \$37,800.00

WHEREAS, the bid submitted by the apparent lowest responsible bidder, Reed & Perrine Sales Inc. has been reviewed by the Superintendent of the Township Water and Sewer Department, the Township's consulting engineer and the Township's solicitor, and found to be acceptable as to form and content; and

WHEREAS, the award of the Contract to Reed & Perrine Sales, Inc. is in conformance with the Township's budgetary constraints.
