**RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE
TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE
OF NEW JERSEY RESCINDING RESOLUTION 2005-653**

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") on November 21, 2005 adopted Resolution 2005-653 entitled "Resolution of the Township of Barnegat, County of Ocean, State of New Jersey, authorizing donation of bicycles to St. Mary's Church; and

WHEREAS, the Township has been advised by St. Mary's Church that they no longer want the donated bicycles because there are too many to sell/give away; and

WHEREAS, the Barnegat Township Police Department has indicated that it would auction the bicycles at the next police auction; and

WHEREAS, this proposal is acceptable to the Township Committee and alleviates the issue regarding an excess of bicycles remaining on Township property.

NOW, THEREFORE, BE IT RESOLVED, this __13th__ day of June 2017, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

1. The Township accepts the recommendations of the Township Solicitor and rescinds Resolution 2005-653.
2. Until further notice all unused bicycles shall be auctioned at the appropriate time by the Barnegat Township Police Department.
3. The Township authorizes and directs the Mayor, Township Clerk, and Township Administrator to execute any and all necessary documents in order to implement the intent of this resolution.
