

RESOLUTION 2017 - 263

RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING AND AWARDED A CONTRACT FOR IT SERVICES, POLICE DEPARTMENT 2017

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the “Township”) has solicited bids for the award of a Contract for IT services for Police Department for 2017; and

WHEREAS, the bids have been solicited pursuant to the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq; and

WHEREAS, three bids have been received in response to the bid solicitation as follows:

GTBM INC.	\$34,995.00
ACSG	\$33,500.00
Pinnacle Consulting Group	\$49,780.00

WHEREAS, the Township has received and carefully reviewed a Letter Memorandum from Lieutenant Keith Germain dated July 6, 2017, which sets forth the reasons that the bids submitted by the apparent lowest responsible bidder, ACSG is not in compliance with the bid specifications, and the proposed material to be supplied would not be compatible with the computer system owned and operated by the Police Department; and

WHEREAS, as a result thereof, the bid specifications of the apparent lowest responsible bidder, GTBM, Inc. have been reviewed by representatives of the Police Department and the Township Solicitor, all of whom found the bid documentation to be acceptable as to form and content; and

WHEREAS, the proposed Contract award is in conformance with the Township's budgetary constraints.

NOW, THEREFORE, BE IT RESOLVED, this 11th day of July, 2017, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

1. The Township accepts the recommendations of the Township Police Department and the Township Solicitor and rejects the bid submitted by ACSG inasmuch as the bid specification submitted by ACSG is not in compliance with the bid specifications demanded by the Township.

2. The Township accepts the recommendations of the Police Department and the Township Solicitor and therefore awards this Contract to GTBM, Inc. for and in consideration of \$34,995.00 per year.

3. The Township authorizes and directs the Mayor, the Township Clerk and Township Administrator to execute any and all necessary documents in order to implement the intent of this Resolution.
