

**RESOLUTION 2017 - 291**

**RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN STATE OF NEW JERSEY, AWARDING A CONTRACT FOR MUNICIPAL DOCK STORM PIPE RE-LINING PROJECT TO EN-TECH CORP.**

**WHEREAS**, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has solicited bids for the award of a Contract for Municipal Dock Storm Pipe Re-Lining Project; and

**WHEREAS**, the bids have been solicited pursuant to the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq; and

**WHEREAS**, three bids have been received in response to the bid solicitation as follows:

En-Tech Corp	\$35,340.00
Swerp, Inc.	\$35,920.00
Arnold Construction Co. Inc.	\$39,300.00

**WHEREAS**, the Township has received and carefully reviewed the bid specifications of the apparent lowest responsible bidder, En-Tech Corp., and have found the bid documentation to be acceptable as to form and content; and

**WHEREAS**, the proposed Contract award is in conformance with the Township's budgetary constraints.

**NOW, THEREFORE, BE IT RESOLVED**, this 1st day of August, 2017, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

1. The Township accepts the recommendations of the Township Solicitor and therefore awards this Contract to En-Tech Corp. for and in consideration of \$35,340.00.

2. The Township authorizes and directs the Mayor, the Township Clerk and Township Administrator to execute any and all necessary documents in order to implement the intent of this Resolution.
