RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY ACCEPTING THE CASH MONUMENT BOND AFFECTING BLOCK 81, LOTS 1.06 AND 1.07, BARNEGAT TOWNSHIP, NEW JERSEY

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has previously received and accepted a Cash Monument Bond in the amount of \$1,500.00 to insure proper construction of monuments affecting Block 81 Los 1.06 and 1.07 (hereinafter referred to as the "Property"); and
