**RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN STATE OF NEW JERSEY, AWARDED A CONTRACT FOR WEST BAY AVENUE BIKE PATH EXTENSION PROJECT TO KLINE CONSTRUCTION**

**WHEREAS**, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has solicited bids for the award of a Contract for West Bay Avenue Bike Path Extension Project; and

**WHEREAS**, the bids have been solicited pursuant to the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq; and

**WHEREAS**, four bids have been received in response to the bid solicitation as follows:

**WHEREAS**, the proposed Contract award is in conformance with the Township's budgetary constraints.

**WHEREAS** that the Chief Financial Officer ("CFO") does hereby certify the availability of funds with respect to awarding a Base Bid Contract to Kline Construction Co., Inc., 240 E. Waveland Avenue, Galloway, NJ 08205 in an amount not to exceed \$191,224.50;
