

## RESOLUTION 2018- 331

### RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, APPROVING THE RELEASE OF A FOUR (4) YEAR AND TEN (10) YEAR STORM WATER INSPECTION AND MAINTENANCE GUARANTY FOR SEA CREST PINES, SECTION 4.

**WHEREAS**, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey has received a request from K. Hovnanian at Fifth Avenue, LLC, for Sea Crest Pines, Section 3, Barnegat, New Jersey for a release of a four (4) year Storm Water Inspection and Maintenance bond, #5033003 in the amount of \$45,256.00 and ten (10) year Storm Water Inspection and Maintenance bond, #5033001 in the amount of \$6,640.00; and

**WHEREAS**, the Township Code, Section 55-291B(6)(f), states that a developer is required to post a 4-year and 10-year Storm water maintenance guarantee for the storm water management system of roads and basins; and

**WHEREAS**, on July 11, 2017, the Township Committee adopted Resolution 2017-262 which agreed to accept ownership of the road and drainage basins in Sea Crest Pines.

**WHEREAS**, a Deed of dedication from D.R. Horton & K. Hovnanian conveying ownership of roads and basins to the Township of Barnegat was dated June 14, 2018 and recorded in the Ocean County Clerk's office on July 17, 2018 in Book 17178, Page 290.

**WHEREAS**, based on the above Deed Dedication to the Township, the developer is no longer required to provide a four (4) year and ten (10) year Storm water Inspection and Maintenance bond; and

**WHEREAS**, the request has been reviewed by the Township Engineer, John J. Hess, PE, PP, CME by letter dated September 7, 2018. The Township Engineer has indicated that he has no objection to the four (4) year and ten (10) year Storm water maintenance guarantees being released for Sea Crest Pines, Section 4.

**NOW, THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey that the request for the release of the 4-year Storm Water Inspection and maintenance guarantee in the amount of \$45,256.00 and the 10-year Storm Water Inspection and Maintenance guarantee in the amount of \$6,640.00 for Sea Crest Pines, Section 4 be released, this 2<sup>nd</sup> day of October, 2018.
