**RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY GRANTING FINAL WATER SYSTEM FACILITIES APPROVAL FOR THE EDGE AT BARNEGAT, A/K/A BLOCK 195, LOTS 7, 8.01, 8.02, 8.03, 8.04, 8.05, 9.01 & 10, A/K/A 59 SOUTH MAIN STREET (ROUTE 9), BARNEGAT TOWNSHIP, NEW JERSEY**

**WHEREAS**, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the “Township”) has received an application for Final Water System Facilities Approval for property known and designated as Block 195, Lots 7, 8.01, 8.02, 8.03, 8.04, 8.05, 9.01 & 10 a/k/a 59 South Main Street (Route 9), Barnegat Township, New Jersey (hereinafter referred to as the “property”); and

**WHEREAS**, in conjunction with the request, the Township has received and carefully reviewed the letter of recommendation dated August 18, 2017 from its consulting engineer for the project, John J. Hess, P.E., P.P.; and
