**RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY AUTHORIZING A REDUCTION OF THE PERFORMANCE GUARANTEE ESTIMATES FOR THE SANITARY SEWER SYSTEM, PRELIMINARY AND FINAL MAJOR SUBDIVISION APPROVAL, PARAMOUNT ESCAPES OCEAN BREEZE - SECTION 3B**

**WHEREAS**, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has received a request for a reduction in the Performance Guarantee Estimate for the sanitary sewer system for the preliminary and final major subdivision, Paramount Escapes Ocean Breeze - Section 3B (hereinafter referred to as the "Property"); and

**WHEREAS**, the request for the reduction has been made by the developer of the property, Paramount Homes; and

**WHEREAS**, in conjunction therewith the Township has received and carefully reviewed the letter of recommendation from its Consulting Engineer for the project, John J. Hess, PE, PP, each dated December 18, 2017; and

**WHEREAS**, the Township finds that the recommendations of its Consulting Engineer for the project are appropriate, and in accordance with the Township Land Use Ordinance.

Cash Guarantee (10%)	\$11,145.00	\$3,344.00
