

**AGREEMENT FOR PROFESSIONAL SERVICES**

**THIS AGREEMENT** dated the **17th** day of **January 2019**

**BETWEEN: TOWNSHIP OF BARNEGAT**, a municipal corporation of the State of New Jersey, having its principal offices located at 900 W. BAY AVENUE, Barnegat, New Jersey 08005 (hereinafter referred to as "Township")

**AND: URGENT CARE NOW, DOCTOR JOHN KULIN**, having his principal place of business located at 712 EAST BAY AVENUE, SUITE 22B, Manahawkin, New Jersey 08050 (hereinafter referred to as "Physician")

**WHEREAS**, pursuant to law, the parties hereto wish to enter into an agreement for Professional Services.

**NOW, THEREFORE**, the parties hereunder do agree as follows:

1. The Physician is hereby retained as Township Physician for a term not to exceed one (1) year commencing January 1, 2019 and terminating on December 31, 2019.

2. The Physician shall provide the following medical services for the following:

3. The parties to this contract agree to incorporate into this contract the mandatory language of subsection 3.4(a) of the Regulations promulgated by the Treasurer pursuant to P.L. 1975, c. 127, as amended and supplemented from time to time and the contractor or subcontractor agrees to comply fully with the terms, provisions, and obligations of said subsection 3.4(a) provided that said subsection shall be applied subject to the terms of subsection 3.4(a) of said Regulations.

4. The parties to this contract agree to incorporate into this contract the mandatory language of section 5.3 of the Regulations promulgated by the Treasurer pursuant to P.L. 1975, c. 127, as amended and supplemented from time to time and the contractor or subcontractor agrees to comply fully with the terms, provisions, and obligations of said subsection 5.3.

5. The Physician shall execute the Affirmative Action Agreement, Exhibit A attached hereto, which shall be incorporated herein be referenced.

6. The Physician shall submit a copy of the Certificate of Employee Information Report or Form AA-304 Initial Employee Information Report prior to any payments being made under this contract.

7. The Township of Barnegat and the Physician for themselves, their heirs, executors, administrators, successors or assigns hereby agree to the full performance of the covenants herein contained.
