

**ORDINANCE NO. 2019 - 3**

**AN ORDINANCE OF THE TOWNSHIP OF BARNEGAT, STATE OF NEW JERSEY AMENDING CHAPTER 41 OF THE TOWNSHIP CODE ENTITLED "CURFEW".**

**NOW THEREFORE BE IT ORDAINED** by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey that Chapter 41 of the Township Code entitled "Curfew" is hereby amended and supplemented as follows:

**SECTION 1.** Section 41-1 of the Township Code entitled "Curfew established" is hereby amended to read as follows:

It shall be unlawful for any juvenile to be on a public street or public place between the hours of 10:00 PM and 6:00 AM.

**SECTION 2.** Section 41-6 entitled "Penalty" is hereby amended and supplement to read as follows:

Any person violating a provision of this Ordinance shall be required to perform community service and a fine of up to one thousand dollars, (\$1,000.00) in the discretion of the Municipal Court Judge. Second and subsequent offenses shall result in increased community service and fines in the discretion of the Municipal Court Judge. If both a juvenile and the juvenile's parent or guardian violate this ordinance, they shall be required to perform community service together.

**SECTION 3.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 4.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 5.** This ordinance shall take effect after second reading and publication as required by law
