

RESOLUTION NO. 2019 – 118

**RESOLUTION OF THE TOWNSHIP OF BARNEGAT,
COUNTY OF OCEAN, STATE OF NEW JERSEY,
AUTHORIZING THE ACCEPTANCE OF A SIDEWALK
EASEMENT FROM D. R. HORTON, INC. – NEW
JERSEY FOR BLOCK 92.56, LOT 7**

WHEREAS, the Township of Barnegat, County of Ocean, State of New Jersey, (“The Township”), has previously requested that the developer, D. R. Horton, Inc.- New Jersey provide a sidewalk easement for property known as 46 Farragut Avenue, otherwise known as Block 92.56, Lot 7 on the Tax Map of the Township of Barnegat (“the Property”); and

WHEREAS, the attorney for the developer has prepared a sidewalk easement conveying to the Township the sidewalk easement area; and

WHEREAS, the Township Engineer and the Township Attorney have reviewed the proposed easement and metes and bounds description and have recommended acceptance of same by the Township;

WHEREAS, the Township accepts the recommendations of its professional staff; and

NOW, THEREFORE, BE IT RESOLVED on this 5th day of March, 2019 by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

1. The Township hereby accepts the deed of sidewalk easement from D. R. Horton, Inc. – New Jersey, as grantor to the Township for property known as 46 Farragut Avenue, Block 92.56, Lot 7 on the Tax Map of the Township of Barnegat.


2. The Township Committee hereby authorizes the Mayor, Township Clerk, and Township Administrator to execute any and all documents necessary to implement the intent of this Resolution.
