

RESOLUTION NO. 2019 –

**RESOLUTION OF THE TOWNSHIP COMMITTEE OF
THE TOWNSHIP OF BARNEGAT, COUNTY OF
OCEAN, STATE OF NEW JERSEY, AUTHORIZING
THE EXECUTION OF AN INDEMNIFICATION AND
HOLD HARMLESS AGREEMENTS WITH BRIGHTON
AT BARNEGAT AND PINEWOOD ESTATES**

WHEREAS, the Township of Barnegat, County of Ocean, State of New Jersey, (the “Township”) has determined that it is beneficial for the residents of Barnegat Township to provide for a second egress from Brighton at Barnegat and Pinewood Estates communities; and

WHEREAS, the second egress will be beneficial in case of an emergency where access to and from the communities is necessary; and

WHEREAS, the Township of Barnegat is willing to provide improvements and removal a fence, trees and shrubs in order to provide for this additional egress; and

WHEREAS, in order undertake the work to complete the egress, the Township must have an indemnification and hold harmless agreement executed by Brighton at Barnegat and Pinewood Estates; and

WHEREAS, the indemnification and hold harmless agreements have been prepared by the Township Attorney; and

WHEREAS, the Township Committee finds it necessary and appropriate to authorize the Mayor to execute the indemnification and hold harmless agreements on behalf of the Township; and

NOW, THEREFORE, BE IT RESOLVED on this 2nd day of July 2019 by the Mayor and Township Committee of the Township of Barnegat, County of Ocean, and State of New Jersey as follows:
