

RESOLUTION NO. 2019 – 270

**RESOLUTION OF THE TOWNSHIP OF BARNEGAT,
COUNTY OF OCEAN, STATE OF NEW JERSEY,
AUTHORIZING THE RELEASE OF A MAINTENANCE
BOND FOR UNITED FAITH CHURCH.**

WHEREAS, the Township of Barnegat, County of Ocean, State of New Jersey (“The Township”) previously accepted a cash Maintenance Bond in the amount of \$12,509.00 on February 7, 2017 for the United Faith Church for property known as 1150 West Bay Avenue, Barnegat, New Jersey; and

WHEREAS, the Township is in receipt of correspondence dated May 29, 2019 from the Township’s Landscape Architect, Scott D. Taylor, and correspondence dated June 21, 2019 from the Township Engineer, Kurt J. Otto, P.E. advising that final inspections have been done and that the professionals recommend release of the Maintenance Bond; and
