**RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY AUTHORIZING PURCHASE OF A CASE BACKHOE THROUGH THE SOURCEWELL COOPERATIVE PRICING SYSTEM CONTRACT #32119-CNH**

**WHEREAS**, N.J.S.A. 40A:11-11(5) authorizes contracting units to establish a Cooperative Pricing System and to enter into Cooperative Pricing Agreements for its administration; and

**WHEREAS**, the Township of Barnegat, has offered voluntary participation in a Cooperative Pricing System for the purchase of goods and services; and

**WHEREAS**, the Township of Barnegat’s Governing Body authorized the Township of Barnegat to become a member of the Sourcewell Cooperative formerly NJPA Cooperative Pricing System, membership #31466; and

**WHEREAS**, the Township of Barnegat, pursuant to N.J.S.A. 40A:11-1 et seq., may by resolution and without advertising for bids, purchase any goods or services under the Sourcewell Cooperative Pricing System for any contract entered into on behalf of the Township of Barnegat; and

**WHEREAS**, GT Mid Atlantic LLC, 200 Bomont Place, Totowa, NJ 07512 is an approved Sourcewell Cooperative Pricing System Vendor; and

**WHEREAS** the Chief Financial Officer (“CFO”) does hereby certify the availability of funds with respect to signing a contract with GT Mid Atlantic LLC, in accordance with the Sourcewell Contract #32119-CNH to accept the lowest responsible price quote for the purchase of Case Model 580 Super N T4F Backhoe for the Public Works Department in an amount not to exceed \$103,931.94;
