

**ORDINANCE NO. 2021-15**

**AN ORDINANCE OF THE TOWNSHIP OF BARNEGAT,  
COUNTY OF OCEAN AND STATE OF NEW JERSEY  
AMENDING AND SUPPLEMENTING CHAPTER 71 OF  
THE TOWNSHIP CODE ENTITLED “VEHICLES AND  
TRAFFIC §71-7.2 THEREOF ENTITLED  
“TRUCK AND BUS EXCLUSIONS”.**

**WHEREAS**, the Barnegat Township Police Department conducted an investigation with regard to commercial vehicles on Hillside Drive and Memorial Drive; and

**WHEREAS**, the Township finds it necessary and appropriate to limit the use of commercial vehicles on Hillside Drive and Memorial Drive consistent with the interests of safety and the expedition of traffic in this area of the Township, and that it conforms to the current standards prescribed by the Manual on Uniform Traffic Control Devices; and

**WHEREAS**, it is in the best interests of the Township of Barnegat to enact a 4-ton weight restriction on Hillside Drive and Memorial Drive for the promotion of the health and safety of the public;

**NOW THEREFORE BE IT ORDAINED** by the Mayor and Township Committee of the Township of Barnegat, County of Ocean, and State of New Jersey that Chapter 71 of the Township Code entitled “Vehicles and Traffic” and specifically §71-7.2 thereof entitled “Truck and Bus Exclusions” is hereby amended as follows:

**SECTION 1.** That Chapter 71 of the Township Code entitled “Vehicles and Traffic”, specifically §71-7.2, subsection (A) entitled “Truck and Bus Exclusions” is hereby amended to include the following additional streets:

<b>Name of Street</b>	<b>Location</b>
Hillside Drive	Entire Length
Memorial Drive	Entire Length

**SECTION 2.** The Township shall install all appropriate measures to advise motorists of the weight restrictions, and shall install and maintain any such measures that are installed in compliance with the Manual on Uniform Traffic Control Devices.

**SECTION 3.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 4.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 5.** This ordinance shall become effective twenty (20) days after its final passage and upon approval by the New Jersey Department of Transportation (N.J.S.A. 39:4-197).

**SECTION 6.** A certified copy of this ordinance shall be sent to the New Jersey Department of Transportation for approval and publication as required by law.
