**RESOLUTION OF THE TOWNSHIP OF
BARNEGAT, COUNTY OF OCEAN, STATE OF
NEW JERSEY, AWARING BID FOR THE PINE
OAK BOULEVARD IMPROVEMENT PROJECT
PHASE II TO EARLE ASPHALT COMPANY**

WHEREAS, the Township of Barnegat, County of Ocean, State of New Jersey (the “Township”) solicited bids for the Pine Oak Boulevard Improvement Project, Phase II (the “Project”); and

WHEREAS, bids were solicited in accordance with the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq; and

WHEREAS, in response to the solicitation of bids, two bids were received; and

WHEREAS, the Township Engineer has reviewed the bids and recommends award of the bid to the lowest possible bidder; and

WHEREAS, the Township accepts the recommendations of its professional staff.

NOW, THEREFORE, BE IT RESOLVED on this 3rd day of August 2021 by the Mayor and the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

1. The Township awards the bid for the Pine Oak Boulevard Improvement Project, Phase II to Earle Asphalt Company for a total base bid plus bid alternates A and B in an amount not to exceed \$292,813.13. The award of the bid is contingent upon NJDOT review and approval and subject to the Township’s budgetary constraints.

2. The Mayor, Township Clerk and Township Administrator are hereby authorized to execute any and all documents to implement the intent of this resolution.
