**RESOLUTION OF THE TOWNSHIP OF
BARNEGAT, COUNTY OF OCEAN, STATE OF
NEW JERSEY, ACCEPTING AND APPROVING A
SHARED SERVICES AGREEMENT WITH THE
TOWNSHIP OF TOMS RIVER, COUNTY OF
OCEAN, STATE OF NEW JERSEY FOR
INFORMATION TECHNOLOGY SERVICES**

WHEREAS, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq., authorizes local units to enter into agreements with any other local unit to provide or receive any shared service that each participating local unit is empowered to provide or receive in its own jurisdiction; and

WHEREAS, the Township Committee of the Township of Barnegat (“Barnegat”) wishes to enter into a Shared Services Agreement with the Township of Toms River (“Toms River”) to share services and reduce costs utilizing the Information Technology (“IT”) unit from the Township of Toms River; and

WHEREAS, the term of the Agreement will be from September 1, 2021 to March 1, 2022; and

WHEREAS, by entering into the Shared Services Agreement, Barnegat and Toms River agree that the shared use of the aforementioned services benefit each public entity equally; and

WHEREAS, Barnegat shall compensate Toms River for the provision of IT services as defined in the Shared Services Agreement, a true copy of which is on file at the Office of the Township Clerk and can be reviewed by the public during normal business hours; and

WHEREAS, all contractual provisions have been negotiated in the aforementioned Shared Services Agreement.

NOW, THEREFORE, BE IT RESOLVED on this 3rd day of August 2021 by the Mayor and the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

1. The Township Committee authorizes the execution of the Shared Services Agreement with the Township of Toms River for the sharing of IT services, a true copy of which is on file at the Township Clerk’s office and can be reviewed by the public during normal business hours.
