

RESOLUTION NO. 2021 – 300

**RESOLUTION OF THE TOWNSHIP OF
BARNEGAT, COUNTY OF OCEAN, STATE OF
NEW JERSEY, AWARDING BID FOR
SOLID WASTE COLLECTION TO
MEADOWBROOK INDUSTRIES, LLC**

WHEREAS, the Township of Barnegat, County of Ocean, State of New Jersey (the “Township”) has solicited bids for solid waste collection; and

WHEREAS, bids were solicited to include various options and the years of the bids varied from 1 year to 5 years; and

WHEREAS, the bids were solicited in accordance with the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.; and

WHEREAS, in response to the solicitation for bids the Township received one bid, from Meadowbrook Industries, LLC; and

WHEREAS, after review of the bid by the Township’s Professional Staff, the Township has determined that it can award the bid based upon the 5 year aggregate to Meadowbrook Industries, LLC for a collection once per week as set forth in the breakdown of the 5 year aggregate:

NOW, THEREFORE, BE IT RESOLVED on this 5th day of October, 2021 by the Mayor and the Township Committee of the Township of Ocean, County of Ocean, State of New Jersey as follows:

1. The 5-year solid waste collection bid is hereby awarded to Meadowbrook Industries, LLC, pursuant to the bid specifications set forth in the bid for a 5-year contract, starting on January 1, 2022 and ending on December 31, 2026 as set forth in the schedule below:
