Be it ordained by the Mayor and Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey:

§ 12B-1 Designation of property.

The Governing Body of the Township of Barnegat, County of Ocean, State of New Jersey hereby designates Block 208 Lots 32 and 33, on the Tax Maps of Barnegat Township, also known as 550 and 560 East Bay Avenue, as "Meadowedge Park."

§ 12B-2. Establish; membership.

The Barnegat Township Committee hereby establishes the Meadowedge Park Advisory Commission:

- A. The membership of the Meadowedge Park Advisory Commission shall be composed of seven (7) members appointed annually by the Township Committee of the Township of Barnegat, said members shall be comprised of the following:
 - (1) Mayor or his/her designee.
 - (2) Recreation Director of his/her designee, to be from either the Recreation Department staff or the Chairman of the Recreation Commission or his/her designee.
 - (3) Five (5) at large members to be appointed by the Township Committee who are Township residents.
 - (4) Alternate I.
 - (5) Alternate II.
- B. Members shall elect a Chairman and Vice Chairman elected from the at large members. A secretary shall be appointed by the Committee from its membership or by resolution of the Township Committee.

§ 12B-3. Terms.

The Township Committee shall appoint all members of the Advisory Commission. The term of the Mayor shall be an annual appointment. The term of the Recreation Director or his/her designee, to be from either Recreation Department staff or the Chairman of the Recreation Commission or his/her designee, shall be an annual appointment. The terms of the members first appointed shall be so determined that to the greatest practicable extent the expiration of the terms shall be distributed. For the initial appointments two (2) at large members shall be appointed for a three (3) year term, and three (3) at large members shall be appointed for two (2) year terms. Alternate I for a two (2) year term, Alternate II for a one (1) year term. Thereafter, all at large members shall be appointed to a two (2) year term and Alternates I and II shall be appointed to a two (2) year term.

§ 12B4. Duties.

It shall be the duty of the Meadowedge Park Advisory Commission to advise the governing body and develop and submit to the governing body an annual budget for approval.

The Advisory Commission shall monitor the use of the park property. The Commission shall monitor the maintenance of the property and report any recommendations to the Township Administrator.

The Advisory Commission shall submit to the Township Committee a report of suggestions for future goals for use of the property with the benefit of all township residents in mind. The Advisory Commission shall establish a list of uses of the property and those organizations associated with the use.

The Barnegat Township Committee will have final approval of any expansion of the use of the property.

§ 12B-5. Meetings.

The Advisory Committee shall hold regular meetings, a record of attendance and business conducted shall be maintained. Meeting dates shall be set by the Barnegat Township Committee by resolution.

§ 12B-6. Compensation.

The members of the Meadowedge Park Advisory Commission shall receive no salary or compensation for their services.
