WHEREAS, the Township Committee of the Township of Barnegat,
County of Ocean, State of New Jersey (hereinafter referred to as the
"Township") also serves as the Township Water and Sewer Utility Department;

WHEREAS, the Township is in need, in order to best protect and provide service to the residents of the Township, of constructing Well No. 9, the accompanying water treatment plant facility, and one million gallon water storage tank (hereinafter collectively referred to as the "water facilities"); and

WHEREAS, Mark Madison, LLC (hereinafter referred to as "Mark Madison") has agreed to, at its own cost and expense, construct the water facilities on property owned by the Township; and

WHEREAS, Mark Madison and the Township have entered into a Reimbursement Agreement which would provide, in part, that Mark Madison would be reimbursed by other users and developers who benefit from the construction of the water facilities, through a formula set forth in the agreement, with the specific understanding and proviso that the Township and its ratepayers will never be financially responsible to reimburse Mark Madison

- 1. The Township accepts the recommendations of its professional staff and accepts and approves the Water Facilities Agreement to be entered into by and between the Township and Mark Madison. - 2. The Township authorizes and directs the Mayor, Township Clerk, and Township Administrator to execute any and all necessary documents in order to implement the intent of this resolution.
