

RESOLUTION 2012-115

Resolution of the Township of Barnegat, County of Ocean, State of New Jersey, to execute a contract under Ocean County Purchasing Contract Number B2011-193 for the purchase of various Public Works Vehicles

WHEREAS, the Township of Barnegat adopted Bond Ordinance number 2011-21 on December 30, 2011, which authorized and allocated \$200,000 for the acquisition of Public Works vehicles and equipment, and

WHEREAS, under N.J.S.A. 40A:11-12, a municipality may, without advertising for bids, purchase materials, supplies or equipment under a contract entered into on behalf of the state by the Division of Purchase and Property in the Department of Treasury, State of New Jersey, and

WHEREAS, there will be substantial savings by the municipality by purchasing under State Contract and utilizing State Contract is in the best interest of the Township of Barnegat, and

WHEREAS, the Township Administrator has determined the acquisition of these vehicles is needed in order to maintain an effective and efficient delivery of municipal services to the Barnegat community, and

WHEREAS, the municipality seeks to purchase this equipment under Ocean County number B2011-193 from the following vendor:

WHEREAS, the Township wishes to purchase two (2) vehicles (trucks) with various options for a total cost not to exceed \$75,000 and
