**RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING EXECUTION OF AN INTERLOCAL AGREEMENT WITH THE TOWNSHIP OF STAFFORD**

**WHEREAS**, the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has been requested to execute an Interlocal Services Agreement with the Township of Stafford (hereinafter referred to as "Stafford"); and

**WHEREAS**, the Interlocal Services Agreement involves the payment for sewerage flow emanating from the Paramount Escapes Ocean Breeze development, in particular, for those homes located within the development and located in Barnegat Township; and

**WHEREAS**, the Agreement provides in part, that Barnegat Township shall be paid the sanitary sewer connection fees for the homes located in Barnegat Township within the Project, and shall reimburse the Township of Stafford for the OCUA treatment expenses incurred for the sewerage emanating from those homes, inasmuch as the sewerage generated from the homes located in Barnegat Township within the Project, will be transmitted through Stafford Township to the southern treatment center located in Cedar Run, New Jersey ; and

**WHEREAS**, the Interlocal Services Agreement has been reviewed by the Township Solicitor and found to be acceptable as to form and content.
