**RESOLUTION OF THE BARNEGAT TOWNSHIP COMMITTEE,
COUNTY OF OCEAN, STATE OF NEW JERSEY, REJECTING ALL
BIDS FOR THE DEMOLITION OF EXISTING IMPROVEMENTS AND
SITE RESTORATION OF BLOCK 159, LOTS 2 AND 3, BARNEGAT
TOWNSHIP, NEW JERSEY, PROJECT.**
