5. Mayor's Report

Memorial Day

Once again I had the pleasure of attending the Memorial Day services held at Fredrick A. Watts Park Sunday morning of the holiday weekend along with marching in the parade on Memorial Day Monday. It was an honor to be allowed to participate in events that recognize the sacrifice made by some so that all of us can enjoy the freedoms we have today.

Would like to thank all who took time out to join us at these events that acknowledge those who have fought and died for liberty and freedom.

Municipal Budget

Tonight on the agenda is the introduction of the town's 2014 budget. This budget reflects funding for the operation of the town along with the water and sewer utility. While the administrator will cover some of the details of the fiscal plan, some of the highlights of the budget are as follows:

- 1. At the April 2014 Township Committee meeting, the township administrator stated that despite the record setting winter, it was his hope that the tax rate increase for 2014 would be less than the 2 cent tax increase of 2013. I am happy and pleased to report that the administrator kept his word and the tax increase for the town for 2014 is ONLY 1.57 cents.
- 2. While the cost of winter operations greatly exceeded \$300,000, the overall increase for the 2014 budget is only \$354,000 or only a 1.6% increase when compared to last year.
- 3. Barnegat is witnessing signs of recovery from both the great recession and Super storm Sandy. New construction and storm restoration work is on the increase in addition to an upswing in the tax collection rate, which in itself is a great indicator of economic conditions. All signs appear to be favorable for 2014 as construction and business activity is increasing for Barnegat, including the repairs at the beach.
- 4. A major reason why Barnegat has been successful with stabilizing taxes and minimizing tax increases over the past several years is because of shared services. Barnegat has been a leader in the state when it comes to developing meaningful shared service agreements that benefit Barnegat taxpayers. In fact, on the agenda tonight is another shared service agreement with Point Pleasant for tax collection services. One (1) reason why Point Pleasant selected Barnegat is due to the solid reputation that Barnegat has when it comes to implementing shared services that yield both operational and financial benefits. A telling measure on how successful Barnegat has been with shared service is that we have agreements from exit 25 to exit 98 on the Garden State Parkway, which is almost 75 miles worth of shared service agreements!

Even though we would all prefer a budget with no tax increase, reality does come crashing in on the budget process resulting in a budget that is responsible and fair considering the extraordinary expenses associated with this past winter. Sitting here on June 2 makes it very easy to forget the harsh winter, but we must keep in mind the fifteen (15) winter weather events requiring the township's response in order to maintain safe road conditions. There is a price tag associated with a comprehensive snow and ice operation.

Overall I am pleased with the budget as it fairly reflects the cost of operations for the town. We are fortunate here in Barnegat to have a dedicated workforce committed

to the well being of the community. Having talented and skilled township employees enhances the ability of the town to remain clean, safe and affordable. In particular, I would like to recognize the efforts of Kathy Janeski, our Chief Financial Officer with preparing this budget. Much work goes into crafting a document that must strike a delicate balance between the financial needs of the town with the fiscal demands being placed on our taxpayers. Once again, Kathy has done an outstanding job with striking that balance. Thank you Kathy for all of your hard work.

Affordable Housing

For second reading and final adoption tonight is an ordinance that will permit the development of an AGE RESTRICTED rental complex at the intersection of route 9 and Georgetown Boulevard. This project will consist of 70 rental units of one and two bedroom apartments. Since this is AGE RESTRICTED, there will be NO impact on the schools.

Even just the mention of an affordable housing age restricted rental development has generated much interest from the community. Obviously there is a high demand for this type of project and I would encourage the committee to vote favorable for this ordinance in order to permit this development to move forward.

6. Committee Reports

Len Morano – We had a very busy Memorial Day weekend remembering those who gave the ultimate sacrifice. Thank you to the residents that support our Veterans. Without the VFW and the American Legion we would not have these events that they plan. When we speak at the schools, they hear about veterans, and they can relate them to the local heroes that they read about. Our concerts have started at the dock, bugs and all.

Memorial Day Services

With the unofficial start of summer comes the extended Memorial Day holiday weekend along with events and ceremonies that honor those who have made the ultimate sacrifice while fighting for freedom. On Sunday of the holiday weekend I had the privilege to attend the Memorial Day Service at Fredrick Watts Park and had an opportunity to speak on the true meaning of Memorial Day.

Then on Memorial Day Monday I had a chance to walk in the annual parade with all the veterans and kids. I wish to thank all that helped with making these events a success as it is very important that we pause and take stock on how fortunate we are to enjoy the freedoms we have today.

Barnegat Summer Savings Program

For the summer, the township will institute a "Barnegat Summer Savings" program which is similar in concept to the "Buy in Barnegat" program of last year which promoted and encouraged residents to shop and buy locally. On Tuesdays and Thursdays through out the summer season, participating merchants will offer a 10% discount on eligible merchandise and services.

At this time, we have about 20 merchants in the program and each business will have a sign in their window indicating participation in the program. No card is necessary and all that is required is for a Barnegat resident to visit a participating merchant on Tuesdays and Thursdays between now and Labor Day to take advantage of the savings.

Again, it is important in order to keep existing businesses successful and to attract new commercial establishments to town, we must keep Barnegat dollars in Barnegat and the "Barnegat Summer Savings" program helps accomplishes that goal.

2014 Municipal Budget

This evening the town will introduce its budget for 2014. Despite the harsh winter, the township was successful with keeping the tax rate increase under last years increase of 2 cents. For 2014, the proposed tax rate increase for the town is 1.57 cents or about 39 dollars on an average assessed house, which equates to roughly an increase of 75 cent per week on the average assessed home.

Local government touches upon the daily lives of each and every resident. Whether it is trash and recycling collection, street cleaning, responding to emergencies or snow plowing, it is the town that provides all of these services to the community. Barnegat Township government never sleeps and works diligently to maintain a clean, safe and affordable community.

Considering the significant cost of this past winter, I am pleased that we were able to produce a budget that is responsible and adequately funds town operations along with minimizing the financial impact on tax payers. Also, I would like to acknowledge Kathy Janeski, our Chief Financial Officer, for a job well done on the 2014 budget. Many hours of hard work goes into drafting the budget and I am appreciative of her efforts. Thank you.

Memorial Day Events

Once again I had the honor and privilege of attending the Memorial Day events held in Barnegat a couple of weekends ago. On Sunday of the holiday weekend was the Memorial Day ceremony at the downtown Gazebo Park which is now called the Fredrick A. Watts Park. The ceremony reflects upon and acknowledges the ultimate sacrifice made by a few so that many can be free.

Also, on Memorial Day itself was the annual parade which starts on Birdsall Street and goes down route 9 to the American Legion where a barbecue is held. It is always a pleasure to see all the kids marching in the parade. Also, this year the parade was lead by the two (2) new Barnegat police motorcycles and I must say the

bikes and officers looked very sharp. As usual, everybody did a great job and I would like to thank the veterans for inviting me to the events.

Affordable Housing

On the agenda this evening for second reading and final adoption is an ordinance that permits an ALL AGE RESTRICTED affordable housing development, consisting of 70 units, to be constructed essentially at the intersection of Route 9 and Georgetown Boulevard which is on the Stafford Township line. Even though the plans for the development have not even been finalized, there has been a strong and positive response to the project with many residents inquiring on how to secure a living unit in the complex.

Recently, the state Council on Affordable Housing issued a draft of Round Three affordable housing requirements and Barnegat had an obligation of over 400 units. Besides complying with the law, there is a strong demand for AGE RESTRICTED affordable rental units and this particular project will provide a viable alternate living arrangement to those seniors who need to downsize or may not have the financial resources they once had.

2014 Municipal Budget

Tonight the township will be introducing the 2014 municipal budget. The budget being proposed this evening is fiscally responsible and minimizes the financial impact on the hard working Barnegat taxpayers. Even with the harsh winter, the proposed budget for the town will increase taxes by 1.57 cents or an additional 39 dollars per average assessed house of \$250,000.

What is even more impressive is since the reassessment in 2011, the average annual tax increase for town operations has been less than a penny a year or roughly 22 dollars per year. Since 2011 and including this year, the overall tax rate increase for the town has ONLY been 3.87 cents.

I support the budget being proposed tonight as it represents a responsible financial plan required to fund town operations. Finally, I would like to acknowledge the efforts of our Chief Financial Officer, Kathy Janeski, with preparing this budget. Many hours of hard work went into this budget and she should be commended for the final product. Thank you Kathy.

Morris Flory – 4 Blue Claw Drive: I am representing the EDC tonight, providing our goals for 2014. Thank you to the Mayor and Administrator for their input. The Board of Education has provided much needed input. The EDC believes the branding and marketing of Barnegat is one of the critical areas of our strategy. What is the committee's recommendation on a Business Advocate? How and where to announce the town wide presentation of the EDC work? Admin: the township is assessing the best approach for Barnegat whether to do that in-house or out source that position. We will utilize the Nixle system to advertise.

Karen Kostick – 12 Hannah Lee Road: there is a parking problem in our neighborhood with the professional plaza on route 9.
