WHEREAS, David Isaksen, Jr., was suspended by the Township of Barnegat without pay on or about March 18, 2015, pending an investigation; and

WHEREAS, David Isaksen, Jr., and the Teamsters Local No. 35 have indicated to the Township of Barnegat that Mr. Isaksen desires to tender his resignation in good standing to the Township of Barnegat; and

WHEREAS, on or about June 4, 2015 the parties did reach an agreement to resolve all matters in difference concerning the employees employment, suspension and separation, the terms of which were reduced to a Confidential Separation Agreement executed by the parties on that date; and

WHEREAS, the Confidential Separation Agreement has been made specifically contingent upon the consideration and acceptance of same by the Township Committee of the Township of Barnegat; and

WHEREAS, the Township finds that the proposed Confidential Separation Agreement is acceptable and in the long-term best interests of the Township and its taxpayers; and

WHEREAS, the form of the Confidential Separation Agreement, has been reviewed by the Township's administrative and professional staff, and found to be acceptable as to form and content:

NOW, THEREFORE, BE IT RESOLVED, this 8th day of June, 2015, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

- 1. The Township accepts the recommendations of its professional staff and approves the Agreement.
- 2. The Township authorizes and directs the Mayor, Township Administrator and Township Clerk to execute any and all necessary documents, including the Confidential Separation Agreement, in order to implement the intent of this Resolution.
