WHEREAS, the Agreement is set to expire in June, 2015 and Barnegat and Point Pleasant have found it necessary to execute this Second Amendment to the Shared Services Agreement extending the expiration date of the Agreement through December 31, 2015; and

WHEREAS, this Second Amendment to the Shared Services Agreement has been negotiated by and between representatives of Barnegat and Point Pleasant.
