WHEREAS, Cardinale and Barnegat Crossings Associates 1, LLC (hereinafter the "Applicant") is the owner of real property known as Block 92.11, Lots 24.10, 24.11 and 24.12 on the Tax Map of the Township of Barnegat (hereinafter the "Property"); and

WHEREAS, Applicant has received amended site plan approval from the Barnegat Township Planning Board to permit the construction of a mixed-use development consisting of age-restricted apartments and commercial uses (hereinafter the "Project); and

WHEREAS, Applicant wishes to proceed with the commencement of construction for some of the required site improvements related to the Project (the "Approved Work"); and

WHEREAS, the Approved Work will be limited to site grading, retaining wall, sanitary sewer main, water main and drainage system for the Project; and

WHEREAS, in order to proceed in beginning the Approved Work on the Project, the Township has requested and Applicant has agreed to execute an Indemnification, Hold Harmless and Release Agreement to discharge the Township from any and all actions and liability related to the Applicant's Approved Work.

NOW, THEREFORE, BE IT RESOLVED, this 17th day of August, 2015, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

1. The Township Committee hereby authorizes the execution of the Indemnification, Hold Harmless and Release Agreement.
