## RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING APPROVAL OF ENGINEERING CERTIFICATE NO. 5 FINAL AND CHANGE ORDER NO.1 TO BEACON CONSTRUCTION FOR WORK COMPLETED ON THE BARNEGAT PUBLIC BEACH CONTRACT #1

**WHEREAS,** the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has previously awarded a Contract for the Barnegat Public Beach Contract #1; and

**WHEREAS,** Change Order No. 1 which reduces the original contract price of \$497,000.00 to \$469,505.37 for a total reduction for Contract #1, Barnegat Public Beach by \$27,494.63

**WHEREAS**, the Township believes that there has been sufficient work completed to authorize Payment #5 Final in the amount of \$22,766.99 and has carefully reviewed the letter of recommendation from its Township Engineer, Adams, Rehmann & Heggan Associates, Inc., dated November 5, 2015; and

**WHEREAS,** in the letter of recommendation, the Township Consulting Engineer has recommended approval of Engineer's Certificate No. 5 Final and Change Order No.1 reducing the total contract price by \$27,494.63, thereby authorizing payment of \$22,766.99 to the Contractor; and

**WHEREAS,** the release of payment No. 5 Final, is contingent upon the Contractor providing to the Engineer all requested closeout documentation; and

**NOW, THEREFORE, BE IT RESOLVED**, this 16<sup>th</sup> day of November 2015 by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

- 1. The Township accepts the recommendations of its Consulting Engineer for the Project and approves Engineer's Certificate No. 5 Final, thereby authorizing payment of \$22,766.99 upon the contractor providing closeout documentation.
- 2. The Township accepts the recommendations of its Consulting Engineer for the project and approved Change Order No. 1 reducing the final contract price by \$27,494.63
- 3. The Township authorizes and directs the Mayor, Township Administrator and Township Clerk, to execute any and all necessary documents in order to implement the intent of this Resolution.
