## **ORDINANCE 2016-06**

AN ORDINANCE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY ABOLISHING THE POSITION OF POLICE CLERK IN THE POLICE DEPARTMENT OF THE TOWNSHIP OF BARNEGAT AND REPEALING ARTICLE THREE OF CHAPTER 15 OF THE CODIFIED ORDINANCES OF THE TOWNSHIP OF BARNEGAT

**BE IT ORDAINED BY** the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, this 1<sup>st</sup> day of March, 2016, as follows:

**SECTION 1.** The Title and Position of Police Clerk with the Police Department of the Township of Barnegat is hereby abolished.

**SECTION 2.** Article III of Chapter 15 of the Codified Ordinances of the Township of Barnegat entitled "Police Clerk", which consists of §§ 15-29, 15-30, 15-31, 15-32 and 15-33 of the Codified Ordinances of the Township of Barnegat, is hereby repealed in its entirety.

**SECTION 3.** Severability. The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of the Ordinance shall not be effected thereby.

**SECTION 4.** Repealer. Any ordinance or parts thereof in conflict with the provisions of this Ordinance are hereby repealed to the extent of such conflict.

**SECTION 5.** When Effective. This Ordinance shall take effect upon final adoption and publication as provided by law.
