NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

WHEREAS, The Township is authorized to purchase certain goods or services from those approved National Joint Powers Alliance Cooperative Pricing System Vendors.

WHEREAS, it's the desire of the Township's Public Works Department through the National Joint Powers Alliance Cooperative Pricing System to utilize CXT, Inc., in accordance with the NJPA contract #022113-CXT to accept the lowest responsible price quote of \$125,050, including freight and delivery for, specifically, one (1) Taos Model chase "Flush" restroom building, pursuant to all conditions of the individual contracts.
