RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, EXTENDING THE EXISTING CONTRACT WITH MEADOWBROOK CARTING, INC. FOR RECYCLING COLLECTION UNTIL NEW BIDS ARE RECEIVED FOR A NEW CONTRACT

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") previously entered into an agreement for recycling pick up, after competitive bidding, with Meadowbrook Carting, Inc.; and

WHEREAS, a prior bid was awarded in accordance with the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.; and

WHEREAS, the Township, in accordance with the Township of Ocean, is in the process of preparing new bid specifications in order to solicit new bids for a new joint contract for recycling collection; and

WHEREAS, an existing contract with Meadowbrook Carting, Inc. expires on or about June 30, 2016, and therefore needs to be extended on a month-by-month basis until the new contract is awarded.

NOW, THEREFORE, BE IT RESOLVED, this 14th day of June, 2016, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

- 1. The Township hereby extends the existing contract for recycling pick up with Meadowbrook Carting, Inc. on a month-by-month basis, under the same terms and conditions as exist in the contract, except that recycling pick up shall be on a one (1) time, every two (2) weeks basis.
- 2. The Township authorizes and directs the Mayor, Township Clerk, and Township Administrator to execute any and all necessary documents in order to implement the intent of this resolution.
- 3. A certified copy of this resolution shall be forwarded by the Township Clerk to the following:

 - (b) Martin Lisella, Township Administrator;
 - (c) Jerry J. Dasti, Esquire; and
