**RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AWARDING BID FOR SOLID WASTE COLLECTION TO MEADOWBROOK INDUSTRIES, LLC**

**WHEREAS**, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (the “Township”) has solicited bids for solid waste collection beginning October 1, 2016; and

**WHEREAS**, bids were solicited to include various options and the years of the bids vary from one year to five years; and

**WHEREAS**, the bids were solicited in accordance with the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.; and

**WHEREAS**, in response to the solicitation for bids the Township received bids from Suburban Disposal, Inc., Meadowbrook Industries, LLC, and Waste Management of New Jersey, Inc.; and

**WHEREAS**, after the bids have been received and reviewed by the Township’s professional staff it has been determined that the bid can be awarded to the lowest responsible bidder, Meadowbrook Industries, LLC, for a five year bid per unit as follows:

**NOW, THEREFORE, BE IT RESOLVED**, this 21<sup>st</sup> day of September, 2016, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

1. The five year solid waste collection bid be and hereby is awarded to Meadowbrook Industries, LLC, pursuant to the bid specifications set forth in the bid for a five year contract total of \$33.56 per month per unit and \$402.72 per unit per year.

2. The Township authorizes and directs the Mayor, Township Clerk, Township Administrator, and Township professionals to execute any and all necessary documents in order to implement the intent of this resolution.
