**RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AWARDED BID FOR THE RECYCLABLE MATERIALS COLLECTION TO MEADOWBROOK INDUSTRIES, LLC**

**WHEREAS**, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (the “Township”) has solicited bids for recyclable materials collection beginning October 1, 2016; and

**WHEREAS**, bids were solicited to include various options and the years of the bids vary from one year to five years; and

**WHEREAS**, the bids were solicited in accordance with the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.; and

**WHEREAS**, in response to the solicitation for bids the Township received bids from Meadowbrook Industries, LLC, and Waste Management of New Jersey, Inc.; and

**WHEREAS**, after the bids have been received and reviewed by the Township’s professional staff it has been determined that the bid can be awarded to the lowest responsible bidder, Meadowbrook Industries, LLC, for Option #3, for a five year contract for collection one time per week as follows:
